- To ensure continuity of care, I have dedicated substantial time over the past year to meeting with and planning the next steps in your patient care with my trusted colleagues at Vibe Health and Spine, **Drs. Sloane Hunter and Jean Paul Bohemier**.

- You may also request to transfer your file to another healthcare provider of your choice. (Files can only be given to a healthcare provider, not directly to you as a patient)
